Below is a typical, auto insurance declaration page. A "Dec" page is a summary of your personal auto policy and will include the insurer's name, policy holder's name, policy number, policy periods, listed vehicles, types of coverage and premiums for the listed vehicles.

Uninsured Motorist Coverage - Stacked or Unstacked

UM Coverage – A Must Have!

Uninsured or Underinsured Motorist coverage (UM / UIM) is not mandatory but provides protection to you, resident relatives, and passengers in your vehicle if involved in an accident with someone who has no liability coverage or not enough insurance to cover your damages.

UM coverage comes in two forms - "Stacked" or "Unstacked." Simply stated, "Stacked" multiplies your limits for this coverage by the number of cars you are insuring. For example, if you have 2 cars in your household

and choose "Stacked" coverage, the UM benefit amount is multiplied by 2. Although this increases your premium, the UM benefits double, thereby providing you with added personal protection. Most importantly, Stacking allows you to expand UM/UIM insurance coverage for a loss if you are in a vehicle other than your own. "Unstacked" limits you to what is documented on the declarations page, regardless of the number of vehicles you own or have insured.

Living in Florida near lakes and canals, it is important to have an emergency seatbelt cutter and window breaker in your vehicle in the event that your vehicle becomes submerged. Seconds can mean the difference between life and death. Every year, approximately 4,800 crashes in the Sunshine State end with a car in the water, causing at least 57 fatalities.

they are about 4 feet 9 inches tall and 8 to 12 years old.
