

Recalled Vehicles: Danger on Our Roadways

45,000,000 Recalled Vehicles Still on the Road

Stricter regulations, standardization of parts, and new technologies have led automakers to increase recalls in the US in each of the last four consecutive years. According to JD Powers, **drivers and vehicle passengers are at significant risk because more than 45,000,000 recalled vehicles manufactured between 2013 and 2015 have not had their defects remedied.**

Data shows that the primary factors affecting recall completion rates are: vehicle age and type, number of cars involved in a recall, type of recall, parts shortages and dealers not receiving parts in a timely fashion. Unfortunately, a high percentage of recalled products are never returned or repaired. Many consumers have either never heard about a recall or have failed to act on a recall. So where do consumers go and what can they do?



What To Do If You Have a Recalled Vehicle or Component

If you received a notice letter or have any questions at all, you should visit government websites such as:

- www.nhtsa.gov.

The National Highway Traffic Safety
Administration (NHTSA) provides recall
information regarding vehicle and equipment
campaigns from 1966 to the present. The
campaigns include motor vehicle products
which experienced a safety-related defect
or did not comply with federal motor vehicle
safety standards.

What's in Your Trunk?

Are Automakers Sacrificing the Spare Tire for Fuel Economy?

Being stranded on the side of a busy highway can be dangerous and scary for any driver; now, imagine you opening your trunk to access your spare tire only to learn there isn't one. The American Automobile Association (AAA) rescued a record 32 million drivers in 2015, including many vehicles that lacked a spare tire.



A AAA Report revealed that thirty-six percent of 2015 model-year vehicles were sold without a spare tire. **Automakers** began eliminating spare tires to make vehicles lighter to meet fuel efficiency standards and to provide consumers with more space. Many consumers are unaware and have a false sense of security thinking they have a spare tire.

The industry has been replacing spare tires with run flat tires, tire inflation kits, or tire repair kits, which are no substitute for a spare tire. These substitutes have their limitations including limited driving ability, product expiration dates, and limited usage, as it may not work based on your specific tire issue.

What to do? When you buy a new vehicle, ask your dealer if it comes with a spare tire. If there is no spare, ask about adding one as an option. Purchasing a spare tire kit, including a jack and tire iron, can cost consumers between \$150-\$600 depending on the car maker. In addition, research other safety options and tools available to you, like inflators, and learn how to use them prior to any emergency.

As with all tires, regular tire maintenance, including visual tire inspection, checking tire pressure, checking for tread wear and rotating the tires, goes a long way to improve your safety.




