

Sovereign Immunity

Caps on Damages for Government Liability: Outdated & Unfair

Did you know that if you are in a car accident caused by a government entity or you are injured on government property, the state or any of its agencies or subdivisions may have no responsibility at all or at best may have **limited responsibility and damage will be capped**?

Florida law shields the government and its employees under the principle of sovereign immunity which is a legal doctrine which has its roots in old England where **"the King can do no wrong."** In the early 1970s, citizens of Florida were barred from suing the state or any of its agencies or subdivisions. In 1975, the Florida legislature enacted Fla. St. §768.28, which provides a partial waiver of Florida's sovereign immunity.

Our Client's Case:

Our client learned about the limitations of the Sovereign Immunity doctrine only after a violent crash caused solely by a Palm Beach County bus driver that changed her life forever (see photos on right). From the beginning, we advised her that under Florida law, damages for government wrongdoing is capped at \$200,000 per person, even if a jury returns a higher verdict. **This cap is simply too low given the cost of medical care today.** Our client's medical expenses already topped \$140,000 and her treating doctors estimated the cost of future medical care over her lifetime at more than \$500,000.

In an interview with CBS 12, **Attorney Scott Murray** calls the government's cap outdated. "These government entities do not take full responsibility for their actions and hide behind sovereign immunity," he said. CBS 12 took our client's case to State Representative Dave Kerner and asked if the cap is fair. Representative Kerner would rather see a system that protects both the state and its residents.

Claims Bill:

Other than simply accepting the \$200,000 capped limit, the only other option for our client is to seek a jury verdict and then take legislative action by filing a claims bill to waive the cap. **Claims bills** start with court judgments that are examined by "special masters" who advise the House and Senate. The claims bill process is no guarantee of a settlement above the cap as success often requires strong sponsorships, good lobbying and strong public relations. In fact, many claims bills never make it to the debate floor and can take three to ten years to process.

While many believe that sovereign immunity is outdated and that the claims bill process is flawed, reform has been unsuccessful. In 2013, a proposal to increase caps to \$1,000,000 to encourage local governments to buy insurance failed the special House committee.

We strongly believe that the rationale underlying sovereign immunity needs to be re-examined and the government should be held fully accountable.

Road Debris

Dangers on Florida's Highways

The AAA Foundation for Traffic Safety reports that between 2011 and 2014, **more than 200,000 car accidents were caused by road debris.** These accidents resulted in 39,000 injuries and 500 deaths. Experts believe these numbers are low as many incidents often go unreported.

According to WPTV, during this same time period, there were more than 450 debris-related crashes in Palm Beach County and the Treasure Coast, affecting almost 750 people and injuring dozens, one fatally.

Palm Beach County has the highest number of road-debris incidents of any county in Florida.

In August 2016, the Florida Department of Transportation (FDOT) collected 83,000 pounds of debris on I-95 and another 9,500 pounds from side roads.

AAA considers debris-related crashes when vehicles:

- Strike or are struck by an object that falls from another vehicle
- Strike a non-fixed object in the travel lane of the roadway
- Attempt to avoid a non-fixed object in the travel lane of the roadway and subsequently crash

Road debris can puncture tires, break windshields, damage undercarriages, and even cause you to lose control of your vehicle where you slide, skid or possibly rollover. Road debris not only causes serious injury to drivers and passengers, but it can also kill.

While these accidents are extremely dangerous, many are preventable.

Prevent Road Debris:

- Maintain Your Vehicles check your tires and exhause system
- Secure Vehicle Loads properly secure and tie down all items (including furniture and ladders) and do not overload vehicle
- Drive Defensively continually scan the roadway looking for hazards and avoid speeding and tailgaiting
- Report Debris call *FHP or local law enforcement to report any roadway debris

Florida No Fault

What does it mean that Florida is a "No Fault" State?

No Fault' DOES NOT MEAN that if someone is at fault for a motor vehicle accident, that the injured party cannot make a claim against them. That is just not true.

No Faus" MEANS that if YOU are hurt in an auto accident and it is not your fault, and you need medical attention, their Riorida law says you must first go through your own sub-insurance company's Personal triping Protection (PIP) benefits of \$10,0000 – for the pay as you go Medical Expenses and for

Your PSP Auto Coverage acts as the primary payor source - EVEN IF you have Health insurance. (Your Health Insurance will then act as a secondary payor source.)
