Be Mindful Before You Post

Nothing You Post Online is Truly Private

Digital, mobile, and social media have been an indispensable part of everyday life. Social media users have passed the 3.8 billion mark. The average internet user now spends 6 hours and 43 minutes online each day viewing and posting life updates/ announcements and sharing personal photos and videos.

Unfortunately, one's private life may no longer be private. Anything you post, type, or comment on (publicly or in private messages) in an electronic device – phone, tablet, computer – could be considered public.

Opportunities for Evidence & Discovery

Did you know that your activity on social media, **regardless of your privacy settings, may be accessible to the other side in a lawsuit? Therefore, you need to exercise caution** when posting, tweeting, sharing, and liking information if you are involved in any kind of legal action, as **your activity may be misinterpreted** and used against you.

Despite Murry Guari's arguments to the contrary, courts sometimes admit information from social media accounts, assuming it is relevant and properly authenticated. If you are involved in a personal injury claim, you can be sure the other side is investigating your social media activity in an attempt to create bias against you or find evidence that appears to conflict with your sworn testimony or what is contained in your medical or employment records.

It is now standard for attorneys or third party investigatory agencies hired by attorneys to search social media for evidence that will help (or hinder) their case. Many companies now advertise their services in carrying out more "in-depth" inquiries. Remember – nothing is truly private!

If you are involved in a lawsuit or plan to pursue one, talk to your attorney about your past and current social media activity, and, if possible, try to refrain from using social media that may be misinterpreted by the other side in a lawsuit.

Dangers on Florida's Highways

Important Road Debris Safety Tips

Tread from a blown tire, trash bags, and cardboard boxes, not to mention any number of items, big or small that have fallen off the back of a truck.

Hitting road debris is dangerous and swerving to avoid it can be just as hazardous.

Florida is one of at least 13 states that can impose jail time if something being hauled falls onto the roadway resulting in serious bodily injury or a death.

Road debris can puncture tires, break windshields, damage undercarriages, and even cause you to lose control of your vehicle, where you slide, skid, or possibly rollover. It not only causes serious injury to drivers and passengers, but road debris can also kill.



These accidents are extremely dangerous, and many of them are preventable. Here are some important safety tips:

- Maintain Your Vehicles check your tires and exhaust system
- Secure Vehicle Loads properly secure and tie down all items (including furniture and ladders) and do not overload your vehicle
- Drive Defensively <u>continually scan the roadway</u> looking for hazards and avoid speeding and tailgating
- Report Debris call *FHP or local law enforcement to report any roadway debris

Engaging Changes, Growth, & Development

John Maxwell is accredited for saying, "Change is inevitable. Growth is optional." This oft repeated quote can be applied to many settings, including our backyards and neighborhoods. South Florida is constantly changing and composed of many municipalities growing at varying rates. Although many areas of our nation have seen decreases in growth and development during the pandemic, South Florida has seen an influx in population, largely from individuals and families relocating for quality of life (and sunshine). As these individuals and families flock to South Florida, some of their employers have followed. And with interest rates near zero, it's not surprising that development is also on the rise. As a result, many Floridians find themselves wanting a bite at the apple, while others want to know what can be done to protect their existing real estate investments and quality of life.

Fortunately, Florida's land use and development laws allow many opportunities for individuals in both camps to participate in the real estate development process. Local Planning Agencies and Boards of Zoning Adjustment serve as release valves for developers seeking to develop structures and uses that vary from regulations and permitted uses. Land use attorneys can evaluate the likelihood of success and alternatives to relief before a project is considered by these agencies and boards. Having a land use attorney as part of a development team may not only increase the likelihood of success for an individual project, it also allows developers to prepare (and preserve) their project for opposition or should the need for an appeal or litigation arise.

Residents and landowners that are concerned about neighboring developments can also benefit from participation in the development process. Florida law affords individuals with a right to speak at most public meetings, which includes meetings of

local Planning Agencies and Boards of Adjustment where projects seeking to vary from development regulations

are considered. Land use attorneys ensure the interests of concerned residents and landowners are adequately considered at these meetings and may challenge decisions adverse to their client's interests. Residents can also form neighborhood groups to represent their concerns at these meetings and increase levels of individual involvement and education. Citizens For Thoughtful Growth and 1000 Friends of Florida are examples of these groups at the local and state levels.

Floridians must play an active role in their communities' planning process to create and preserve desirable communities that protect and promote their real estate investments. Playing an active role always involves engagement, and residents and property owners are well advised to consider engaging a land use attorney as they interact with the development process to ensure their interests are protected and promoted. Change is inevitable, but growth is optional. Increased engagement in the local development process helps ensure that growth occurs in a way that is desirable for all Floridians, newcomers and old timers alike.
