# Alarming Statistics on Road Rage and Fatal Crashes in the US

According to the National Highway Traffic Safety Administration (NHTSA), aggressive driving behaviors, which can lead to road rage incidents, are a factor in over half of all fatal crashes in the United States. A survey conducted by the AAA Foundation for Traffic Safety found that almost 80% of drivers expressed significant anger, aggression, or road rage behind the wheel at least once in the past year. Another survey by the same organization found that 56% of fatal crashes involved at least one driver who was reported to have shown aggressive behavior or engaged in road rage. Also, according to a report from the advocacy group Everytown for Gun Safety, more than 550 people were shot in road rage incidents in the U.S. in 2022. That means someone was fatally shot or injured in a road rage incident every 16 hours, on average.

These statistics highlight the importance of promoting safe driving habits and taking measures to prevent aggressive behavior on the road.

## **Possible Reasons for the Rise in Road Rage Incidents:**

There is no definitive answer to why road rage incidents are on the rise, but possible reasons are:

- Increased congestion and traffic: As more people hit the roads, traffic congestion has become a significant problem in many cities. This can lead to increased frustration, impatience, and aggressive driving behaviors.
- Personal stress and frustration: Many drivers face various stresses in their daily lives, such as work pressure, family issues, financial problems, etc. These stressors can lead to heightened emotions and an increased likelihood of engaging in road rage incidents.
- Easy access to technology: Smartphones and other gadgets have become ubiquitous, and drivers may be distracted by them, leading to frustration and anger.

## When To Consider Partition Actions in Real Estate

A Partition Action is a civil lawsuit to force the sale of Florida real estate. Florida law allows property to be owned jointly by several persons or entities. Often times, joint owners of a property cannot agree on the management or sale of a property or even one joint owner does not want to sell. So, a **Partition Lawsuit** is a request by one owner to the Court to force the sale of the property.

There are many reasons why Florida property owners may decide that a partition of property is needed. The three (3) most common reasons are when children inherit property and become joint owners, when an unmarried couple owns property jointly and then split up, or when a business partnership dissolves and cannot agree on the division of its assets.

A partition action can be filed by a joint owner of a property, except if the property is owned by a husband and wife as tenants by the entireties. The Defendants to the lawsuit are all of the other owners of the property. The lawsuit must be filed in the County in which the property is located.

Once a lawsuit for a partition is filed, the court must decide whether the property should be sold and how the proceeds of the sale should be divided amount the owners. **Some owners may be entitled to receive a higher share of the sale proceeds for improvements or contributions that they made to the property and things such as mortgage payments or**

**property taxes.** If there are mortgages or liens on the property, the mortgages and liens must be satisfied from the sale proceeds before the remainder is divided amongst the owners. Each owner is responsible for a share of the attorney fees and court costs, which are incurred for the action.
