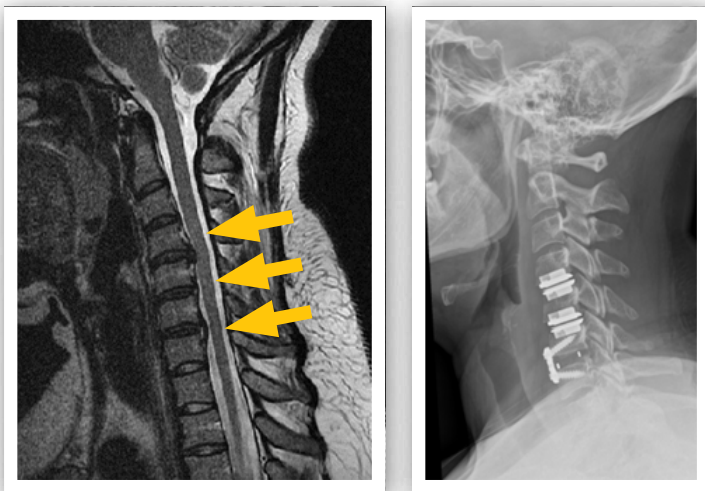

Significant Confidential Settlement

Attorneys Jason J. Guari, Esq., and Keith R. Hedrick, Esq., resolved a motor vehicle crash claim for a substantial settlement. This incident occurred when a commercial vehicle failed to yield to our client's right-of-way by pulling out directly in front of her vehicle, causing a "T-Bone" collision. At the scene, our young, seat-belted client experienced neck pain, went directly to the hospital, and had significant injury findings revealed in her diagnostic studies. She ultimately underwent a very serious, three-level neck surgery – (a two-level disc replacement and one-level fusion – *shown below on the right*)).

Prior to filing a lawsuit, the commercial insurance carrier did not offer any money to resolve the claim. Without any other options, continued pain, mounting medical bills, and

loss of income, the team at Murray Guari Trial Attorneys filed a lawsuit on behalf of our client. Through discovery, we proved that the

driver of the commercial vehicle was 100% responsible for causing this crash, and our client's injuries, and the need for surgical intervention was caused by this heavy impact. Our client was relieved to finally resolve this claim for a confidential amount and to begin to move forward with the rest of her life.

Major Hotel Chain Fails to Warn of Defective/Slippery Shower Surface

Attorneys Scott C. Murray and Keith R. Hedrick recently settled a premises liability claim for a significant confidential amount against a major hotel chain. This unfortunate incident occurred when our client, who was staying at the hotel, stepped into the shower and encountered an unusually slippery surface – likely caused by the use of a cleaning product on the floor. The slippery surface caused him to fall backwards, hit the back of his head on the threshold and strike the left side of his body including his shoulder and knee. Once he was able to gather himself, he immediately reported the incident to the staff. **Please note that the report of an incident is extremely important in a premises liability case and should always be done whenever someone is injured from a fall.**

From the fall, our client sustained injuries to his shoulder, knee, and back. After undergoing injection therapy for both, as well as surgery to his knee, our client had vast improvement in his pain and symptoms.

Throughout the course of this claim, the hotel chain attempted to blame our client for the fall which forced Attorneys Murray and Hedrick to file a lawsuit and litigate this matter. After over a year of litigation, our team negotiated a fair and just settlement for our client.

Pickup Truck Rear-Ends Vehicle at PGA BLVD – \$270,000 Policy Limits Paid

A 5,400 pound, 2011 GMC Sierra 1500 pickup truck rear-ended our client's white Nissan while she was stopped facing north at PGA Boulevard and I-95. The impact was so heavy that it pushed her vehicle into PGA Boulevard's eastbound traffic only to get **struck a second time**.

Although she had her seatbelt on, and all the airbags inside her vehicle deployed, she still suffered neck, low back, and head injuries from the massive force of the crash. Her injuries required our client to undergo physical therapy and orthopedic and neurologic treatment.
