\$300,000+ Settlement for Driver Hit by Commercial Vehicle

Law Partners **Jason Guari** and **Scott Perry**, had the privilege of representing a hardworking and upstanding member of our community who was hit by a commercial truck driver who had no business being on the roadway.

When our client was rearended early in the morning on a long straight roadway by a driver, who evidence supported had a history of being in possession of paraphernalia when driving a commercial truck, she suffered a serious exacerbation of a prior low back injury. Despite evidence from her treating doctor and her treating worker's compensation doctor that this crash was the cause of her need for surgery, the defense made a low-ball offer and claimed everything was pre-existing.

With that, the case was put into litigation and the pressure was applied to the defendants and their insurer. After months of litigation when the insurance company realized this case was not going to resolve for the pennies on the dollar we were

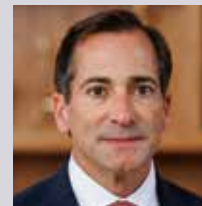
able to push the case into an early global mediation. There, the insurance company again tried to avoid fairly

compensating our client; however, when confronted with caselaw indicating that they were exposing themselves and their insureds to bad faith, the tune swiftly changed resulting in a fair settlement for our client with the active tortfeasors.

After the underlying case resolved, we were able to **secure the entire policy limits for the Underinsured Motorist (UIM) coverage** allowing for a full recovery on behalf of our client – despite its first offer being only 10% of the policy limits. We were able to quickly show that the carrier's initial evaluations were inadequate.

Progressive Continues to Delay, Deny, and Force Litigation

Partner Scott Perry recently resolved another case with Progressive after it tried to do everything it could to avoid paying on our client's case. On a clear-cut case, Progressive tried to avoid paying anything to our client – including blaming our client for the crash. It did not work!

Our client was less than a mile from her home, when she was turning left with a green turn arrow when an 18-year-old driving a sports sedan was speeding through the same intersection and failed to stop for a red light, striking our client's SUV and then coming to rest a several hundred feet down the road. The distance the other driver traveled after the heavy impact showed the speed, well over the speed limit, that the inexperienced driver was traveling. Below you can see the damage from the crash.

Progressive, the at-fault driver's carrier, ignored every demand and all of the evidence and claimed that our client was at fault. After multiple opportunities to re-evaluate its position on liability, Murray Guari Perry filed suit.

This caused Progressive to have a new litigation adjuster to review the file. The new adjuster admitted that he did not understand the position of the prior adjuster when confronted with the speeding and the running of the red light by the tortfeasor and tendered the policy limits. This was followed by a tender of the policy limits for the Underinsured Motorist Carrier a few days later. Progressive's actions delayed the resolution of our client's case for no purpose but to keep money in its pockets for longer, earning Progressive interest.

If an insurance company refuses to evaluate a claim fairly, the team at Murray Guari Perry is here to fight and make the insurance company pay when it should! ■

MGP Resolves Personal Injury Claims for Family in Disputed Liability Crash While in a Rideshare Vehicle

What started as a routine ride home quickly turned into a terrifying nightmare when an uninsured driver sped through a red light and violently broadsided a rideshare vehicle in which our clients were passengers. The impact lifted the vehicle onto two wheels and nearly caused a rollover. Fortunately, our clients had the foresight to carry Uninsured Motorist (UM) coverage.
